Original research paper reports the results of original research.
- b) Technical Paper
Technical paper gives complete description of specific application of technique in short (4 to 5 pages).
- c) Review Article
Review article reports the progress, shortfall, views, approaches, trends, etc. reported in previous research.
- d) Editorial
Views of editor-in-chief on articles or chapters included in the proceeding will be published as editorial may be in the form of first article. It should be submitted as article.
- d) About conference and proceedings
It will be appeared on webpage as ‘about book’. Please submit as article.

5 GENERAL GUIDELINES

5.1 Documents and Order

Use MS Word to prepare the manuscript and submit original files through [Manuscript Portal™](#) for book. Save files as First Page, Main text, Table, Figure, Captions, etc. File of Main text may be named as Manuscript with initial of author e.g. Manuscript_vsb or Chapter_1, Table as Table_1, Table_2, Figure as Figure_1, Figure_2,

The manuscript should be submitted in the following order:

a) First Page

Title,
Author details: Author name(s), Affiliation(s) with address,
Correspondence: Address(s), email, Fax, Telephone, Cell phone, etc.
Author for Correspondence: Address(s), Email, Fax, Telephone, Cellphone, etc.
Funding agency, Funding Awards, etc.

b) Main text,

Title (without author details),
Abstract (150 words),
Key words (4 to 6),
Introduction,
Body (methodology, results, discussions, findings, conclusions),
Acknowledgements,
No conflict of interest(s),
Endnotes,
References

c) Tables

d) Figures

e) Captions

5.2 Language

We prefer plain American English for manuscripts submitted to all books of **GATHA COGNITION™** however, manuscripts prepared in British and Indian English are also acceptable.

5.3 Font and Size

Use regular font, 'Times New Roman', size 10pt for manuscripts. Avoid use of *Italics* however, it suggested for special words like vernaculars or regional languages.

5.4 Paragraph and Spacing

Paragraph should be formatted with **Single Line Spacing**, give 6pt before and after the paragraph(s) as well as heading(s).

5.5 Headings and Subheadings

We accept headings up to **three levels**.

1. HEADING LEVEL - I

Capital and bold,
Numbers- 1, 2, 3,
Start numbers from Introduction or Background, exclude abstract and key words.

1.1 Heading Level - II

Capitalize each word (exclude words like the, in, and, etc.)with bold.
Numbers- 1.1, 1.2, 1.3, 2.1, 2.2, 2.3,

1.1.1 Heading level - III

Italic
Numbers- 1.1.1, 1.1.2, 1.1.3, 1.2.1, 1.2.2,

5.6 Citations

All references listed at the end of manuscript, tables, figures, etc. should be cited in the text at appropriate places as:

- a) References
 - Single author: (Bhagat, 2002),....Bhagat (2002)
 - Two authors: (Smith and Warner, 2002)
 - Authors more than two: (Smith *et al.*, 2006)
 - Two or more citations: (Bhagat, 2002; Smith and Warner, 2002 and Smith *et al.*, 2006)..... Bhagat (2002) Smith and Warner (2002) and Smith *et al.*, (2006).....
- b) Table(s): (Table 1), (Table 2),
- c) Figure(s): (Figure 1), (Figure 2).....
- d) Equation(s): (equation (1))

5.7 Quotations

Author may quote generic texts from published literature to enrich the manuscript using single ‘.....’ as well as double “.....” with proper citations.

5.8 Footnotes

Footnotes may be given at the end of manuscript.

5.9 Mathematical Issues

1. Equations should be composed using ‘Equation formats’ available in MS Word.
2. Use standard units, symbols, universal constants, functions, etc. for representation of mathematical data.
3. Equations should be numbered as: (1), (2), and cited in the text as (equation (1)), (equation (2)).

5.10 Figures

1. Only high quality figures are acceptable for publication of article. Please scan images at the resolution: 1200dpi for line art, 600dpi for greyscale and 300dpi for color images.
2. Figures should be saved in separate files as TIFF, JPG and PNG.
3. Figures must be numbered (Figure 1, Figure 2, ...) in the order of they appeared in the text.
4. Figures must be captioned and all captions should be provided on separate page.
5. All axes on graph must be labeled and units (km², m, kg,.....) clearly stated.
6. Map or remote sensing images should have:
 - a) North arrow and scale bar with clearly stated units.
 - b) Location information with standard geographical coordinates.
 - c) Borders should be carefully mapped from authentic maps only.

5.11 Highlights

Author should provide 4 to 6 bullet points to highlight the important aspects of the article including background, methodology, findings, conclusions, etc. Each bullet point should be less than 70 characters including spaces. Highlights appear only on web pages.

5.12 Graphical Abstract

A graphical abstract is summary of main findings of the article presented in graphical form i.e. image, graph, picture, map, formula, etc. It will be used to show main findings of the article, graphically in online version. Graphical abstract helps reader to capture the research findings at a glance. All graphics i.e. images should be prepared at 300 dpi with preferred file types- TIFF, JPG and PNG.

5.13 List of References

References should be listed alphabetically at the end of manuscript as below:

Author name [surname and initials], year of publication. Title of article. *Name of the journal (Italic)*, number of volume (issue number), page numbers.

Author name(s) [surname and initials], year of publication. *Name of the book (Italic)*. Edition, publication, city (country), page numbers.

6. Thesis and Dissertation

Author name(s) [surname and initials], year of submission. Title of the Thesis/dissertation. Degree, name of the University / Organization, city (country), page numbers.

7. Patents

Author name(s) [surname and initials], year of publication. Title of the patent. Patent number.

8. Web pages

Give URL and mention the date of accession.

9. DOI (Digital Object Identifier)

Articles with DOI are citable in manuscript submitted to books. Mention DOI in citations.

Please Note

1. Appendices

Appendices are not required and accepted for articles published in books.

2. Figure(s)

Each figure should be in separate file.

3. Authorship

a) Leading person in reported research and preparation of manuscript should be mentioned as the first author of the article.

b) All persons involved in reported research and preparation of manuscript must be named in the manuscript as co-authors.

c) Corresponding author must be authorized and agreed by all author(s) for all correspondence required for publication of the manuscript.

4. Affiliations

Manuscript must be contented full name and contact information including detailed address, telephone numbers, emails, etc. of organization, research institute, etc. where authors are working and research undertaken. Please note that no change will be accepted after manuscript accepted for publication in book.

5. Author name(s) and affiliation(s) should be mentioned on the 'first page', only.

6. Funding agencies

Author(s) should mention funding agencies and grant awarding bodies helped for research incorporated in the article. Please mention details [e.g. scheme or grant number, year] of grants or awards received for the research.

7. Biographical note

Biographical notes are not required for this journal.

8. Use plain English and avoid discriminatory, sexist or racist terms and language.

9. Tables are prepared in word processor and editable.
